1. Apologies for absence.

Apologies received from Councillors M Bearpark & M Gardner.

2. Minutes of last Meeting.

The Minutes of the last meeting having been circulated were approved with one amendment and signed.

3. Matters Arising.

NYCC say they do not think their sign has caused the blocked drain.

4. A Direct payment Request for the 2 ½% Consolidated Stock was signed.
