3. Matters Arising.

  - 4.1 Yorkshire Dales National Park Authority - have given consent for the felling of one white Poplar at Highfields, Back Lane.
  - 4.2 Yorkshire Dales National Park Authority – have given consent for the felling of 2 large conifers at Sundale house.

  6. The corner near the Post Office needs trimming to avoid wagons damaging the Green.
