## MINUTES of a meeting held on

Monday 23<sup>rd</sup> January 2012 at 7pm

- 1. There were no apologies for absence other than Councillors R Gale & J Blackie.
- 2. The Minutes of the last Two Meetings had been circulated and after amendment of those present at the December meeting, they were approved and signed.
- 3. Matters arising
  - 1. The Dormobile at Healaugh was still unregistered and parked.
  - 2. The Clock has stopped again. The Clerk to contact Mr Herbert and W Potts of Leeds.
  - 3. £16.40 was handed to Cllr. Allinson from Healaugh Honesty Box.
- 4. Correspondence had been received as follows:
  - 4.1 Yorkshire Dales Access Forum looking for new members.
  - 4.2 Planning consent for The Laurels.
  - 4.3 Richmondshire Eco Group wondering if we want to plant some trees.
  - 4.4 Payment of £76.23 for grass cutting received from NYCC.
  - 4.5 National Park approval to remove crown from 1 ash tree at Garden House, and remove 1 cherry laurel at The Manse, Reeth.
  - 4.6 Councillor F Butler re: cost of play parks.
  - 4.7 "Just the Job" providing employment opportunities for people with special needs.
  - 4.8 North Country Theatre.
  - 4.9 RDC re: Play equipment. A copy was passed to Cllr. Gardner and a copy is to be sent to W Whitehead. The Clerk is to find out what is the minimum inspection required by Insurers and at what level of competence.

- 14.1 Cllr Gardner had given Tony Sunter permission to fence the Green off near the Post Office.
- 14.2 The meeting considers that more money should be received by the District Council from the business rates paid to Central Government for funding public toilets.
- 14.3 Street lights RDC81 Silver Street/ Langhorne Drive needs attention as does No: 4 Quaker Close.
- 14.4 There are 28 dislodged setts and Highways should be invited to inspect them.
- 14.5 An oil wagon going onto the Green near the Burgoyne had caused damage.
- 14.6 The tree opposite Reeth Garage is interfering with telephone wires.
- 14.7 There is damage to the Green near the Ice Cream Parlour.
