MINUTES of a meeting held on Monday 27th February 2012 at 7pm in Reeth Memorial Hall

1. No Apologies for absence
2. The Minutes of the last meeting had been circulated. After amending paragraphs 14.1 & 4.10 the Minutes were approved and signed.
3. Matters arising
 1. The Dormobile at Healaugh is being taxed
 2. Smith of Derby are to let us have a Report on the Clock
 3. W Whitehead to be reimbursed any costs incurred in attending the Play Parks Training at Richmond
 4. Cllrs D Allinson and M Gardner had inspected the Green at Healaugh in the light of the letters from Richard Tarran & Dr Raitt and reported no visible problem but he will monitor the situation
