MINUTES of a meeting held on Monday 24th September 2012

- 1. Apologies for absence : None.
- 2. The Minutes of the last Meeting having been circulated, were approved and signed.
- 3. Matters Arising:
- 3.1 It was suggested that signs from the Market Place to the Playground and the Doctors Surgery should be ordered, but the meeting felt that only a sign to the Doctors should be considered and only if Dr Brooke so wishes. The matter to be considered at the next meeting.
- 3.2 The Clerk is to contact Mr W Emms, Agent for the Nickerson estate, with a view to registering parts of Healaugh Village Green at the Land Registry.

- 9. Health & Safety Assessments and Financial Risk Assessments. The meeting does not feel that these Assessments are necessary.

- 11. The Accounts have now been audited.
- 12. Any other business.
 - 1. Fun Fair. Councillor Allinson will read the meter next year before and after the fun Fair as all the electricity now comes from the Council's main supply.
 - 2. The clerk is to liaise with Councillor Allinson and the approved contractors in formulating a plan for relaying or replacing cobbles next year. Councillor Gardner proposed and Councillor Kendall seconded that we approach Richmondshire Funding Scheme for finance.
 - 3. The mower should be sent to Ripon Farm Services for servicing.
 - 4. It has been reported in a local paper that a claim can be submitted for new play equipment up to £2000 (including Safety Matting).
 - 5. Neither the drain in Back Lane (where the concrete and pipe is broken) nor the footpath near Mrs Clarkson have been attended to.
 - 6. A light pole in Langhorne Drive was knocked over near George Alderson's house and has been removed.
 - 7. Raw Bank cattle grid is loose.
 - 8. Councillor Gardner requested the Clerk to write to County Highways requesting a coordinated plan to cut back the saplings on the roadsides and Councillor Frankland commented on the saplings on the Healaugh Road.

The Clerk to send details to the Chairman of Richmondshire District Council now and inform other parties in mid October.
