## MINUTES of a Meeting held at The Memorial Hall Reeth on Monday 20<sup>th</sup> May 2013

**Present:** Councillor Bearpark (Chairman) Councillors OJ Kendall D Allinson G Frankland RW Rutter & M Gardner, District Councillor R Gale, IC Scott (Clerk) and 4 members of the public.

- 1. Apologies for absence were received from Councillor J Blackie & Mrs Tracy Little.
- 2. The Minutes of the last meeting held on 22<sup>nd</sup> April 2013 were read approved and signed.
- 3. Matters Arising.
  - 1. Any liability for maintaining cobbles at Healaugh will lie with the person who organised them.
  - 2. There are many setts needing re-setting all over the edge of The Green.
  - 3. All the stone flags on the Bandstand should be taken up and relaid.
  - 4. The traffic lights do not always work because thieves take the batteries.
  - 5. County highways are still waiting for the Report on the main road repairs.
  - 6. The Clerk to check that the names of approved contractors has been updated.
  - 7. According to our records there are 38 seats in the Parish.
- 4. Correspondence had been received.
  - 1. From Mrs Ogilvie querying the decision not to have a sign to the Playground.
  - 2. A letter of thanks from SWAAG.
  - 3. £100 had been received from Mr Morrison towards the cost of the bench restoration on Back Lane. He is arranging a plaque.
  - 4. Arkengarthdale Parish Council had written to say that the gatepost at Raw Bank is broken. The Clerk to contact NYCC.
  - 5. Details of York Minerals Waste Plan had been received.
- 5. Lamposts and Wall at Fremington.

The lamposts at Fremington & Langhorne Drive have been replaced but need to be Commissioned. They will be painted as soon as they have weathered. The broken wall at Fremington needs urgent attention as it is a bad advert for the Village.

  - 1. The Clerk to continue with research for the additional names.
  - 2. The Clerk to arrange for the Memorial to be pressure washed and the rails painted.

The Clerk to write objecting to the application principally on the grounds of road access. The road had been a "substandard road" in 1983 and unacceptable then. Nothing has changed. It is not a "No through Road" but part of the highway to Hurst.

- 2. The Shelter. The guttering and down pipe needs renewing.
- 3. Light RDC 8 at Back Lane is not working.

  - 1. The tarmac near the Telephone kiosk needs replacing.
  - 2. The Clerk to write to the occupier of South View who parks his car on the pavement resulting in damage to the green.
  - 3. It is not thought that a new litter bin is required.
