

GUIDANCE FROM THE NFU

When reading the following notes please check as necessary the latest update with your local officer or with MAFF.

1) Farmers can only move animals to slaughter if they have a licence from their local trading standards office.

2) Producers in a declared infected area and within 8km of a holding covered by a

form C will not qualify.

- 3)A producer issued with a form D, which has been lifted and has not had any livestock moved onto the premises in the last 21 days, may have a licence issued.
- 4) Form D's have an expiry date and from this date animals may be moved under licence.
- 5) In extreme cases the restriction time of a form D may be unlimited: in this case it will be lifted through the issue of a form E after an inspection.
- 6) Producers who have moved livestock onto their premises within the last 21 days will need to give the name and further enquiries to be made.
- 7) Before a licence is issued trading middle of the next week at the earliest. standards will need producers to inform them of the species and type of livestock to be moved, the numbers, the proposed date of movement, destination and route. The name of the abattoir and specific booking time is also required to ensure animals have a minimum waiting time with the least risk of exposure to infection.
- 8) Producers will also have to sign a declaration on the day of the intended move that the animals are free from foot and mouth. This must accompany the Animals along with the movement licence.

- 9) Normal provisions for moving livestock still apply: they must be correctly tagged, have passports, animal transport certificates, sheep movement documents, schedule 2 pig movement forms an d so on. Movement records must be completed as required under existing legislation, including movement registers required on farm, at abattoirs and collecting centres.
- 10) If there are any problems with identification or documentation, the animal will not be permitted to return to the holding and will be destroyed and disposed of.
- 11) Animals should be presented in a manner fit for slaughter, clear and dry, and where necessary clipped. Animals which do not meet the standard will be held to the end of slaughter, at which point they will be disposed of. If there is difficulty in meeting the clean livestock policy, farmers are advised not to send animals direct to slaughter.
- 12) Draft proposals have been drawn up for operating collection centres for beef and sheep intended for slaughter and it is hoped address where the animals came from for MAFF will have the scheme finalised by Friday 9th March and operational by the
 - 13) OTMS cattle will be channelled through collection centres with other livestock.
 - 14) MAFF advises that licences are collected by post or in person, as faxes and e;mails are open to forgery and fraud. However, the advice states licences should only be collected in person from trading standards offices in exceptionally urgent cases, such as where cattle are approaching 30 months.
 - 15) Livestock places must be booked at abattoirs before farmers apply for movement licences: anyone giving false information to trading standards is in danger

Foot and Mouth - Advice to Farmers

How to protect your farm

This leaflet provides information on preventative measures on how to protect your farm against foot and mouth disease. Further measures apply if your farm is in a declared infected area.

The following measures should be followed:

- * You should ensure you maintain the highest standards of hygiene for all movements on and off your farm.
- * Have only one combined entrance and exit. Display the name of the farm and the telephone number on the gate. Keep the gate locked.
- * Provide a means of contact between farm entrance and house for essential callers, e.g. a bell or a gong. Supply a tub of disinfectant, a brush for scrubbing footwear and a spray pump. Keep the disinfectant solution clean-renew it daily.
- * All vehicles entering and leaving the premises should have their wheels sprayed with approved disinfectant.
- * Stop all non-essential vehicles and visitors from entering the farm and arrange whenever possible for collection and delivery of supplies to take place at farm boundary.
- * Keep a record of all deliveries. In the event of disease being confirmed this may help in epidemiological investigations.
- * Where possible, house all the animals or keep them away from the perimeter of your farm.
- * Ensure you complete all records of stock movements as required by existing legislation.

If you have more than one farm, then:

- * Treat each as a completely separate unit. Make separate arrangements for labour, management and feeding.
- * Keep dogs, cats and poultry under control.
- * Make every effort to destroy rats and other vermin. They may spread disease.
- * Keep your stock away from household waste, bones or swill.
- * Limit contact with other peoples livestock and with other keepers of livestock. Should you have any contact with them, before you go near your own animals, disinfect your footwear, change your clothes and wash with hot water and soap, including your hair. Any item or object that may have had contact with disease must also be disinfected.

Disinfection and approved disinfectants

A dirty surface must be cleaned before it can be satisfactorily disinfected. The dirt may make the disinfectant useless. It is therefore most important that anything which must be disinfected is first soaked with an approved disinfectant, then thoroughly washed and cleaned and finally washed down with an approved disinfectant.

You must use an APPROVED DISINFECTANT

A list of those approved for use against foot-and-mouth disease and the dilutions at which they must be used are available on the MAFF website.

Members of the public are warned that all public rights of way in the county have been closed by statutory notice, over 10,000 notices have been posted on footpaths across the county and the public are advised that persons disobeying these notices are liable to a fine of £5000.

As a preventative measure the county council have installed disinfectant soaked mats on all entry/exits points from open moorland roads crossing cattle grids which should catch all vehicular traffic using these roads.

of being prosecuted. Animals not booked in and where there is no spare capacity may be left until the end before being slaughtered and disposed of.

16) When booking abattoir time, farmers should determine whether straw is allowed for bedding. Animals making short journeys to the abattoir may not need bedding, as this will make disinfection procedures easier. During the foot and mouth crisis nearly all clubs, leagues and organisations have now cancelled or suspended their activities. Please check before travelling to any event to ensure that the event is still on and the area you intend to travel to is not a closed or infected area. Best not to go.
